**An Act to amend the Municipalities Ordinance**

[20TH SEPTEMBER, 1963]

ENACTED by the Parliament of Tanganyika.

1. This Act may be cited as the Municipalities Ordinance (Amendment) Act, 1963, and shall be read as one with the Municipalities Ordinance (hereinafter called the Ordinance).

2. Section 39 of the Ordinance is hereby amended by inserting immediately below section 39B thereof the following new section to be numbered 39C:—

39C.—(1) A council may make advances and operate deposit and suspense accounts within such limits and upon such conditions as shall be approved in writing by the Minister.

(2) The municipal treasurer shall be responsible for controlling such advances and such deposit and suspense accounts as are approved under subsection (1)."

3. Section 43 of the Ordinance is hereby amended by inserting immediately below subsection (5) thereof the following new subsection to be numbered (6):—

"(6) Where any dispute arises between the council and the inspector as to the reasonableness of the latter's fees and charges in respect of the preparation of his report and his other duties under this section, the dispute shall be referred to the Minister whose decision thereon shall be final."

4. Section 49 of the Ordinance is hereby amended by inserting immediately below subsection (3) thereof the following new subsection to be numbered (4):—

“(4) A council may provide within the municipality suitable parking places for vehicles, or may authorize the use of any part of a public road, street or square as a parking place, and may impose charges to be paid to the council in connection with the use of any such parking place by any vehicle or class of vehicles and may install mechanical or other apparatus for the purpose of ascertaining such charges.”

5. Section 54 of the Ordinance is hereby amended—

- a) in paragraph (9) thereof by inserting immediately after the word “therein” occurring at the end of the paragraph the comma and words “, to prohibit the sale of any specified produce within the area of jurisdiction of a council otherwise than in a market”;
- b) in paragraph (25) thereof —
  - (i) by deleting the word “to” at the beginning of the paragraph and substituting therefor the words and commas “whether within or, with the consent of the Minister, without the Municipality to”;
  - (ii) by deleting the colon at the end of sub-paragraph (d) and substituting therefor a semi-colon and adding immediately thereafter the following new sub-paragraph to be lettered (e):—
 

“(e) community centres and travellers’ or residential hotels.”

Section 70  
of Cap. 105

6. Section 70 of the Ordinance is hereby amended—

- (a) by inserting immediately before the word “regulating” in the third line of paragraph (28) (q) thereof the words “requiring and”; and
- (b) by inserting immediately after sub-paragraph (e) of paragraph (37) thereof the following new sub-paragraph to be lettered (f):—
 

“(f) for regulating the use of parking places whether in streets or not, prescribing the conditions upon which and the classes of vehicles by which such parking places may be used, prescribing the amount of charges for the use of such parking places, the person liable to pay and the method of recovering the same, and regulating, controlling, inspecting and maintaining any apparatus (whether of a mechanical nature or otherwise) installed for the purpose of ascertaining the amount of such charges.”
