An Act to amend the Customs Tariff Ordinance

[6TH FEBRUARY, 1963]

ENACTED by the Parliament of Tanganyika.

1. This Act may be cited as the Customs Tariff Ordinance (Amendment) Act, 1963, shall be read as one with the Customs Tariff Ordinance, and shall be deemed to have come into operation on the sixth day of February, 1963.

Short title, construction and commencement Cap.

2. Section 3 of the Customs Tariff Ordinance is hereby amended by adding the following new subsection:—

Section 3 of Cap. 346 amended

“(4) Notwithstanding the provisions of subsection (1), where any imported crude or partly refined petroleum is removed for refining to a refinery licensed as a bonded warehouse, the import duties and suspended duties on such petroleum shall instead of being charged on the importation of that petroleum, be charged on the delivery of any goods from the refinery for home consumption and shall be the same as those which would be payable on the importation of like goods.”

3. The First Schedule to the Customs Tariff Ordinance is hereby amended as follows:—

First Schedule to Cap. 346 amended

(a) by adding immediately below item 3 the following new item:—

(c) by deleting item 41 and by substituting therefor the following new item:—

41	Dressings, surgical, admitted as such by the Commissioner—		

- (a) White absorbent cotton wool ... *Ad valorem* 25 per cent
 (b) Sanitary towels and tampons ... *Ad valorem* 25 per cent
 (c) Other Free
 (d) in item 43, by re-lettering paragraph (d) as paragraph (e) and by inserting the following new paragraph (d):—

- (d) rope, cordage, twine and string, n.e.s. *Ad valorem* 12½ per cent

(e) in paragraph (a) of item 51A, by inserting immediately after the word "plates" the comma and word ", trays";

(f) in paragraph (l) of item 58A, by re-lettering sub-paragraph (d) as sub-paragraph (e) and by inserting the following new paragraph (d):—

- (d) Enamelled, printed, lithographed, embossed or lacquered *Ad valorem* 25 per cent

(g) in paragraph (2) of item 58A, by deleting sub-paragraph (c) and by substituting therefor the following new paragraphs:—

 (d) Other Free

(h) in item 98, by deleting the entry in the column headed Import Duty, and by substituting therefor the following new entry "Per Imperial Gallon at 62°F. Sh. 1/50";

(i) by deleting item 132, and by substituting therefor the following new item:—

132 Books, printed and printed matter—

- (a) Directories, guide books, literature, music, newspapers, periodicals, leaflets and pamphlets, not including advertising leaflets and pamphlets ... Free

- (b) Printed work books and question books for educational purposes; printed or lithographed religious texts ... Free

- (c) Carnets de passage, pass sheets and similar international temporary importation forms; posters framed or unframed, unframed photographs and photographic enlargements and printed window transparencies advertising the tourist attractions of foreign countries provided that such goods are for free distribution and do not contain more than 25 per cent private commercial advertising ... Free

- (d) Catalogues, price lists, show cards, brochures, leaflets, pamphlets and similar printed matter advertising goods grown or produced, or services to be supplied from, outside East Africa and imported for advertising purposes only, but not including calendars, diaries, date indicators, desk pads or other advertising stationery ... Free

- (e) Rims and suspenders imported for the manufacture of calendars Free

- (j) in item 137, by re-lettering paragraph (d) as paragraph (e), and by inserting the following new paragraph:—

(d) Reinforced waterproof paper ...	<i>Ad valorem</i> 12½ per cent	”;

- (k) in paragraph (c) of item 165, by adding at the end of subparagraph (ii) the semicolon and words “; empty seed packets”;

- (l) in item 165, by deleting paragraph (d) and by substituting therefor the following new paragraph:—

ARTICLE	IMPORT DUTY	SUSPENDED DUTY
(d) Wrapping paper—		
(i) waxed, grease-proof, laminated foil and laminated cellophane ...	Free	”;
(ii) Other, unprinted ...	Free	”;

- (m) in item 165, by re-lettering paragraph (g) as paragraph (h), and by inserting the following new paragraph:—

ARTICLE	IMPORT DUTY	SUSPENDED DUTY
(g) Bags, layflat tubing, and sheeting printed and unprinted, of polythene or similar film ...	<i>Ad valorem</i> 12½ per cent	”.
