An Act to amend the Hide and Skin Trade Act, 1963

ENACTED by the Parliament of the United Republic of Tanzania.

1. This Act may be cited as the Hide and Skin Trade (Amendment) Act, 1965, shall be read as one with the Hide and Skin Trade Act, 1963 (hereinafter referred to as "the principal Act"), and shall come into operation on such date as the Minister shall, by notice in the *Gazette*, appoint.

2. Subsection (1) of section 2 of the principal Act is hereby amended by inserting, immediately before the word "cleaning" in the definition "preparation", the word and comma "flaying".

3.—(1) Subsection (3) of section 3 of the principal Act is hereby amended by deleting the words and comma "farmer, grazier or butcher" where they occur in the first and second lines and in the fifth line, and by substituting in each case the words "farmer or grazier".

(2) Section 3 of the principal Act is hereby further amended by adding, immediately below subsection (3), the following new subsection:—

"(3A.) The provisions of subsection (1) shall not apply to the preparation, storage or delivery by a butcher of hides or skins which have been flayed by him in the course of his occupation as such."

4. Subsection (3) of section 4 of the principal Act is hereby amended by deleting the words and comma "farmer, grazier or butcher", where they occur in the first and second lines and in the fourth and fifth lines, and by substituting in each case the words "farmer or grazier".

Transitional 5.—(1) Notwithstanding the provisions of the principal Act as amended by the foregoing provisions of this Act, subsection (1) of section 3 and subsection (1) of section 4 of the principal Act shall not apply to any person who, immediately before the commencement of this Act, carried on the occupation of a butcher and was, by virtue of such occupation, then exempted from the application of the said subsections, until the expiration of six months from the commencement of this Act.

(2) Notwithstanding subsection (1) of section 7 of the principal Act, where a licence is issued under section 6 of the principal Act to any such person as is referred to in subsection (1) of this section during the year in which this Act comes into operation, such licence shall, subject to the provisions of section 8 of the principal Act, remain in force until the thirty-first day of December in the year next following.
